Auking Mining Limited – (ASX: AKN) – Anticipated Reinstatement to Official Quotation

Description

The securities of Auking Mining Limited ('AKN') are expected to be reinstated to Official Quotation at the commencement of trading at 10:00 AM AEST on Tuesday, 15 June 2021, following its re-compliance with Chapters 1 and 2 of the ASX Listing Rules. AKN raised \$7 million pursuant to the offer under its prospectus dated 9 March 2021 as supplemented by the First Supplementary Prospectus dated 19 March 2021, the Second Supplementary Prospectus dated 23 April 2021, the Third Supplementary Prospectus dated 4 May 2021, the Fourth Supplementary Prospectus dated 31 May 2021 and the Fifth Supplementary Prospectus dated 3 June 2021 ('Prospectus') by the issue 35,000,000 shares at an issue price of \$0.20 per share and 17,500,000 quoted options exercisable at \$0.25 per option expiring on Friday, 30 June 2023.
