


REE Occurrences – Mt Isa Inlier




Elaine - REE Copper Cobalt Uranium

Elaine West – New Copper and Rare Earth Element Zone

- New overlapping copper and REE zones. To be extended by drilling.
- Drilling to infill resource to the east and along strike north and south.
- Intercept and follow up drilling will aim to extend Inferred JORC Resource Total Rare Earth Oxides (TREO).
- First results from visual sulphide zones in early July 2011.



Elaine - REE Copper Cobalt Uranium




