 - 8.8.1 Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not?

Answer: No. It is expected that limited (if any) on ground activities will be possible in either Tanzania or Western Australia until April, after conclusion of the annual wet seasons in both jurisdictions. This will have the effect of reducing the entity's funding requirements for the short term.

8.8.2 Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Answer: The entity successfully completed a short-term share placement in November 2023 and proposes to take further steps during the March 2024 Quarter to secure additional funding for its proposed activities in Tanzania and Australia. These steps are expected to be successful based on support from the existing Board and key shareholders. The terms of any further raising will be dependent on the market conditions at the time.

8.8.3 Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?

Answer: Yes. The entity holds mineral project interests (uranium and copper in particular) that are still well supported by investors, despite the prevailing difficult market conditions for junior exploration companies. As a result, the entity remains confident that it will be able to continue to meet its business objectives.
